Following shall be the guidelines of the association that both parties shall follow:

1. Both parties will work together in good faith to make the collaboration reach an effective outcome success and each party agrees that, except in the eventuality of gross negligence or flouting of norms by the participant or its representatives/staff, neither will be liable to the other for any kind of eventuality or losses that are caused due to or associated with holding such kind of events.

2. GENERAL DELIVERABLES FROM THE SKILLS PARTNER: (Party 1)

- i. Guest sessions & workshops (2 to 3 per academic year) on topics of interest for the students and faculty of the institute in the areas of expertise of the "Skills Partner".
- Career counselling or making students aware about latest career opportunities available in civil engineering.
- iii. Industrial site visits (2 to 3 per academic year) for the students and faculty of the institute at network construction sites of the "Skills Partner".
